Non-refundable deposit of 25% is required on placement of order, full settlement with 30 days of order.

All prices are shown in GB Pounds (Sterling). When you reach the checkout any shipping charges will be added to give you the total amount to be paid.

We are not currently VAT registered, so there is no VAT on any prices, and we cannot issue you with a VAT invoice.

Our payment service providers are BACS, Stripe or PayPal so you can be sure that of your details are safe.

Delivery is direct from our UK manufacturer by courier to your chosen location within mainland UK.

There is a **minimum order requirement of six units on all ordered items**.

Shipping outside of the UK must be agreed in advance.

All International orders are shipped using the Royal Mail International Tracked service.
